## The LIFE Blue Lakes Project

The current state of science on the topic of microplastics in water bodies requires further research. This is why seven partner organisations, led by the Italian NGO Legambiente, have launched the EU-Life project "Blue Lakes" on this complex issue.

The LIFE Blue Lakes project contributes to the reduction of microplastics in lakes in Europe. The increasing contamination with microplastics has long-lasting negative effects on lake ecosystems and their unique biodiversity. The measures are implemented exemplarily at Italian and German lakes. The measures are aimed at local authorities, businesses, and the communities in the lake regions. Results and experiences will be made available to organisations at other lakes in Europe that are engaged in lake protection.

A special focus is on developing concrete recommendations for action for municipalities, elaborating a white paper for lakes, conducting a dialogue with relevant economic sectors and to raise awareness among consumers on how to reduce the consumption of plastics and microplastics in everyday life. Methods for monitoring microplastics and more efficient technologies for filtering microplastics in wastewater treatment plants will be developed and a broad transfer of knowledge to relevant experts will be ensured. Moreover, the project contributes to achieving the objectives of the European strategy for plastics as foreseen in the transition process towards a circular economy.
